**SPAY/NEUTER AGREEMENT**

Revised February 8, 2020

(1) \_\_\_\_\_ Adopting person(s) agrees that Basset Hound Rescue of Georgia (hereafter BHRG) **Dog No.** \_\_\_\_\_ will not be used for breeding purposes.

(2) \_\_\_\_\_ Adopting person(s) agrees to have **BHRG Dog No.** \_\_\_\_\_ spayed by the age of six (6) months, no later than (date) \_\_\_\_\_ pursuant to O.C.G.A. §4-14-3.

(3) \_\_\_\_\_ Adopting person(s) have paid the adoption fee of **\$ 300.00** for **BHRG Dog No.** \_\_\_\_\_. BHRG agrees that at the time written confirmation of a spay/neuter by a licensed veterinarian and a telephone follow-up by an officer of BHRG of the same, a **\$ 50.00** refund (from the \$300 adoption fee) to the adopting person(s) will be made.

(4) \_\_\_\_\_ Adopting person(s) agrees that failure to spay/neuter **BHRG Dog No.** \_\_\_\_\_ by the above date will result in forfeiture of **BHRG Dog No.** \_\_\_\_\_ and the adoption fee. Adoption person(s) further understands that Georgia Code Section 4-14-4 states that it shall be a misdemeanor to fail or refuse to comply with the requirements of Code Section 4-14-3 requiring the mandatory spay/neuter within 30 days of reaching the age requirement, and any person convicted of said misdemeanor shall be subject to a fine not to exceed \$200.00.

(5) \_\_\_\_\_ Adopting person(s) agrees that this spay/neuter agreement constitutes final notice of the spay/neuter requirement and no further notice is required to institute legal action for violation of the terms of this contract.
